

Affidavit of Heirship Form Instructions

- 1. First, download and save the form to your computer.
- 2. **Open** the saved form from where you saved it on your computer.
- 3. **Type** in your information, completing all fields.
- 4. **Print** the form and sign it with a notary present.*
- 5. **Scan** and **save** the completed and signed Affidavit of Heirship form to your computer.
- 6. **Scan** and **save** the item(s) noted below to your computer.
 - a. If a decedent left a will, attach a certified copy thereof.
 - b. If executor or administrator has been appointed for the estate of decedent, attach a copy of the certificate of appointment from the Court which made the appointment.
 - c. If administration on decedent's estate has been completed and final order or decree of distribution has been rendered, attach certified copy of such order or decree.
 - d. The completed, properly executed Affidavit should be recorded in the County where the property described on page 1 of the Affidavit is located.
 - e. If necessary, you may attach the land description on a separate attachment.
- 7. **Email** all scanned documents to ownerrelations@crescentpass.com.
